VIII. Unfinished Business:

a. Administration and Finance Committee: Commissioner Zec, Chair

Board Secretary: Commissioner Zec made a motion, seconded by Commissioner Coursey to accept the recommendation of the Administration and Finance Committee to approve the appointment of Marty O'Brien as Board Secretary. **Ayes: Commissioner Ashta, Coursey, Zec, Fergus and Burdi. MNASR Board Member Appointment: Commissioner Zec made a motion, seconded by Commissioner Coursey to approve the appointment of Commissioner Fergus as the Morton Grove Park District MNASR Board Member. Disposal Ordinance: Commissioner Zec made a motion, seconded by Commissioner Coursey to approve Ordinance #O-01-15, authorizing the disposal of surplus Park District property. **Ayes:** Commissioner Zec, Fergus, Ashta, Coursey and Burdi. Nays: 0. Absent: 0. Motion carried.

Updated Tree/Bench Donation Policy: Commissioner Zec made a motion, seconded by Commissioner Coursey to accept the recommendation of the Administration and Finance Committee to approve the new Donation Policy, which updated the tree donation program into a policy which includes trees and benches and to add the policy to the Park District General Use Regulations Chapter II, Section 5. **Ayes: Commissioner Fergus, Ashta, Coursey, Zec and Burdi. Nays: 0. Absent: 0. Motion carried.**

Auditor Review: Commissioner Zec made a motion, seconded by Commissioner Coursey to accept the recommendation of the Administration and Finance Committee to authorize Interim Executive Director, Marty O'Brien to execute a 3 year contract with the audit firm of Lauterbach & Amen for an amount not to exceed \$43,500 to perform the Park District audits. **Ayes: Commissioner Ashta, Coursey, Zec, Fergus and Burdi. Nays: 0. Absent: 0. Motion carried.**

b. Recreational and Facility Program Committee: Commissioner Coursey, Chair

Multi-Child Discount: Commissioner Coursey made a motion, seconded by Commissioner Fergus to accept the recommendation of the Recreation and Facility Program Committee that the Board of Park Commissioners adopt the new multi-child discount for gymnastics, dance, preschool, B-4, and BASE programs beginning in the summer of 2015. A 10% discount for two children and a 15% discount for three children will apply. Ayes: Commissioner Coursey, Zec, Fergus, Ashta and Burdi. Nays: O. Absent: O. Motion carried.

Alcohol Sales on Park District Property: Commissioner Coursey made a motion, seconded by Commissioner Zec to accept the recommendation of the Recreation and Facility Program Committee that the Board of Park Commissioners approve alcohol sales at future Park District programs and special events. Memorial Day Weekend Concert at Harrer Park: Interim Executive Director explained that the Village is planning a Memorial Weekend event which they would like to hold at Harrer Park. Several of the Commissioners were concerned about the short time-line, number of people using the parks and the damage to the grass. They also wanted more information regarding the revenue, liability, and the promoter. It was agreed to appoint Commissioner Zec, Burdi and Director O'Brien to enter into further conversation with the Village to help make an informed decision.
